
This Instrument Witnesseth That the Board of Regents for and on behalf of the Education Department of the State of New York at their meeting of November 15, 2016.


An application having been made by and on behalf of the trustees of the FES (Free Enterprise Sports) Academy, for an amendment of its charter, it was

Voted, that the provisional charter of the FES (Free Enterprise Sports) Academy, located in Brooklyn, county of Kings, and state of New York, which was granted by action of the Board of Regents under the corporate name "FES Sports Academy" on September 23, 1983; amend to change the corporate name to "FES (Free Enterprise Sports) Academy" and made absolute on January 20, 1988 be, and the same hereby is, amended to change the corporate name to "Minority Enterprise Career Schools" and to revise the purposes to provide for the operation of grades nine through twelve.
